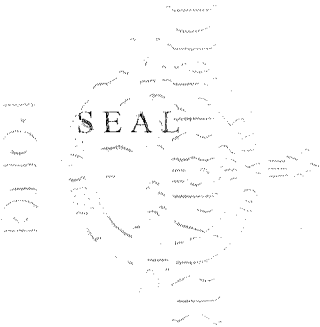

## DETAILS

On above date and time, the undersigned was dispatched to 101 West San Augustine to investigate a reported fight in progress.

Upon arrival, SOURCE, DELORIS A. PROFIT, Store clerk, at 101 West San Augustine, met with the undersigned and pointed out SEAN MATTHEW KILEY, subsequently identified above as SUBJECT, who was sitting on the passengers side of a brown truck. The undersigned requested that SUBJECT exit the referenced truck in order to interview him about the disturbance. SUBJECT exited the referenced truck from the passengers side and the undersigned observed in plain view a pair of brass knuckles laying on the floor board where SUBJECT's feet had been. SUBJECT then orally stated that he had borrowed the brass knuckles and that they were not his. The undersigned confiscated the brass knuckles, tagged them, and subsequently released them to evidence custodian, Lieutenant W.P. BESS for safekeeping.

Upon interviewing SUBJECT, he stated that his date of birth was 6 February 1971 (16) and a reported was made through the Juvenile Division of the Deer Park Police Department. It was later learned through the Harris County Juvenile Probation Department that the SUBJECT's birth date was 6 February 1970, making him 17 years old, an adult.

On 7 May 1987, at 1:05 AM, a "to be" warrant for Possession of Prohibited Weapon was filed against SUBJECT through the Harris County District Attorney's Central Intake Division.

On 7 May 1987, at 3:22 AM, a probable cause was sent via telecopier from the Harris County District Attorney's Central Intake Division to the Deer Park Police Department.

On 7 May 1987, at 10:56 AM, warrant number 947033 was issued against SUBJECT for Possession of Prohibited Weapon from Harris County Criminal Court at Law #13, setting his bond at \$500.00.

On 11 May 1987, 12:24 AM, the undersigned with the assistance of Pasadena Police patrolmen MIKE R. HOFFMAN, employee number 3446, arrested SUBJECT at his residence at 1407 West Harris, Pasadena, Texas. The undersigned





On above date and time, DELORES PROFIT, Store Clerk, 7-11 Store, 101 West San Augustine, Deer Park, Texas, telephoned the Deer Park Police Department and reported that two individuals were about to fight in the parking lot and they were creating a disturbance.

Officer L.S. MARTIN was dispatched to investigate and upon his arrival, PROFIT pointed to a brown Chevrolet pickup where one of the combatants ran to. MARTIN requested that SEAN KILEY, fully identified above as DEFENDANT, exit the vehicle in order to interview him about the disturbance. DEFENDANT exited the passenger side of the brown pickup and MARTIN observed in open view a pair of brass knuckles laying on the floor board where DEFENDANT's feet had been. DEFENDANT orally stated to MARTIN that he had borrowed the brass knuckles and they were not his.

MARTIN confiscated the brass knuckles, tagged them, and subsequently released them to Evidence Custodian, Lieutenant W.P. BESS for safekeeping.

MARTIN was unable to locate the other combatant. MARTIN took DEFENDANT into custody and transported him to the Deer Park Police Department where he was released to his mother.

On 24 February 1987, 4:00 PM, MARY JONES and her son, DEFENDANT, met with the undersigned at Deer Park Police Department, Juvenile Bureau, and they were advised a report would be sent to Harris County Juvenile Probation.

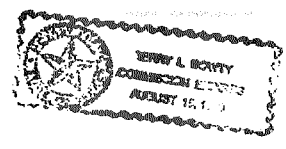
